Does the horse/pony possess a passport? If so, then please send it to us, with this completed form and the FEI will issue a cover passport. We cannot issue a FEI cover without seeing the existing passport.

Due to DEFRA regulations horses should already have an existing passport. Therefore most of the FEI passports issued will be FEI cover passports. This means that a purple cover with additional pages will be put round your existing passport eliminating the need for a vet to come out and complete a new passport.

In the event that a horse/pony has no passport whatsoever we will issue a full new FEI passport which will need to be completed by a vet.

Passports are valid for 4 years. If you are changing the ownership on an FEI passport please note you will need to change it with British Dressage as well.

If the horse is jointly owned, ALL owners must be recorded in the passport. If the horse/pony is owned by a company, then, the 'Individual Responsible' must be given as well as the company name.

PASSPORT PROCESS

1. Horses / Ponies must be registered with British Dressage
2. Horses/ Ponies must be FEI registered (Forms available from BD office)
3. Passport received in BD office
4. Office order passport from BEF
5. BEF process the passport (This process can take a up to 2 wks during busy times)
6. BD then send the passport back to the owners for signing and additional work
7. Owner to send passport back into BD office for final stamping
8. BEF process the passport (This process can take a up to 2 wks during busy times)
9. Validated passport is returned to owner / rider.

EMERGENCY PASSPORT VALIDATION

In exceptional circumstances the BEF will validate a passport within a 48 hour period. For this service the BEF will charge £68.00 on top of the cost of the passport. Therefore it is in your best interest to check passports regularly and order new passports well in advance so you do not incur any additional costs.
